The Committee (VC Selection), on behalf of the Department of Agricultural Research and Education (DARE), invites applications from distinguished academic leaders for the position of Vice Chancellor, Central Agricultural University, Imphal, Manipur

Established in 1993, by an Act of Parliament the Central Agricultural University, Imphal, stands as a premier institution under the Department of Agricultural Research and Education, Government of India. It holds a unique position as a fully residential university with jurisdiction that covers seven North-Eastern Hill states: Arunachal Pradesh, Manipur, Meghalaya, Mizoram, Sikkim, Nagaland, and Tripura.

The university operates through a decentralized network of 13 constituent colleges and six Krishi Vigyan Kendras (KVKs) to meet the specific agro-climatic needs of the North-East region. The constituent colleges of the university are located across the seven states, covering diverse fields such as Agriculture, Veterinary Sciences, Fisheries, Horticulture, Forestry, Agricultural Engineering, Community Science, and Food Technology. The six KVKs located in Manipur, Arunachal Pradesh, Mizoram, Meghalaya, and Tripura, serve as "Farm Science Centres" for technology dissemination.

CAU Imphal is recognized for its integrated approach to agricultural development, focusing on producing globally competitive graduates and postgraduates capable of serving as scientists, entrepreneurs, and progressive farmers. It plays a critical role in providing food and nutritional security to the North-Eastern region by developing sustainable and profitable farming systems tailored to the local environment. By establishing specialized research laboratories and "transfer of technology" centers, the university ensures scientific innovation reaches practical application for farmers and agro-industries. Finally, CAU maintains active partnerships with national and international institutions, as well as state development departments, to enhance its teaching and research capabilities

Job Description

The Vice-Chancellor is the principal executive and academic officer of the University and he exercises general supervision and control over the affairs of the University and gives effect to the decisions of all the authorities of the University.

Skills and Competencies

The person is expected to have the following:

- a. Outstanding scientific achievement to his/her credit in the field of agriculture or allied sciences
- b. Record of successful administration and management of science preferably of agricultural education/research/extension at a higher level.
- c. Modern and forward looking approach with broader scientific perspective particularly in the field of agricultural education and research.
- d. Vision and proven leadership qualities to communicate and inspire academic, research, extension and administrative staff.
- e. Initiative and innovative abilities.
- f. Experience of interaction with other academic and research organizations at National/International level.
- g. He/ She should have the highest level of integrity, morals, professional competence and institutional commitment in addition to academic distinction.

Educational Qualification and Experience

- i. Should have a Ph.D. degree in any branch of agriculture or allied sciences.
- ii. Should be an eminent scientist/teacher having at least 10 years experience as Professor or equivalent including 3 years experience in Research/Teaching/ Extension management.
- iii. Should have evidence of contributions to Teaching/Research/Extension as supported by publications/innovations and demonstrated leadership.

Term of office

The Vice-Chancellor shall hold office for a term of five years from the date on which he enters upon his office, or until he attains the age of seventy years, whichever is earlier, and he shall be eligible for reappointment for a further term of five years, or until he attains the age of seventy years whichever is earlier.

Emoluments, Condition of Service and Pay

The emoluments and other conditions of the service of the Vice-Chancellor shall be as per the provisions of the Central Agricultural University Act, 1992. The pay of the post of Vice -Chancellor will be as per Ministry of Education/ UGC Regulation (O.M No. No.1-7/2015-U.II(1) dated 02.11.2017, revised time to time). The Present Pay of the post is Rs. 2,10,000/- fixed and other allowances as per Government of India rules.

Selection Procedure

The Committee for the selection to the post of Vice Chancellor has been duly constituted with the approval of President of India in his/her capacity of Visitor of CAU, Imphal. The Committee will evaluate and recommend the appropriate number of persons/ candidates after screening and examination of the applications to the Hon'ble President of India (Visitor of CAU, Imphal) through Hon'ble Agriculture and Farmers' Welfare Minister for consideration and selection to the post of Vice Chancellor as per CAU, Act, 1992.
