The Interview Schedule will be notified separately. **The candidates are advised to regularly visit the Board's website for requisite updates.** The Interview call letters will be issued to the provisionally qualified candidates through their e-mail address given in the application form only. **Kindly note that no information/ interview call will be made by post.** If any candidate fails to receive the interview e-mail 10 days prior to the date of interview of the respective discipline, he/ she may contact the Examination Section, ASRB on phone no. 011-25846166 or e-mail id: [soexam@asrb.gov.in](mailto:soexam@asrb.gov.in). Further instructions/ information regarding Interview will be issued in due course.

4. The appearance of a candidate in the interview will be purely provisional. If at any stage, the Board finds that the candidate does not fulfil any of the prescribed eligibility conditions, his/her candidature is liable to be rejected. The candidates are also advised to go through the eligibility conditions as mentioned in the ASRB's Notification for Combined NET, ARS, SMS (T-6) and STO (T-6) Examination-2025 [No. 1(1)/2025-Exam dated 24.02.2025 and Addendum No. 1(1)/2025-Exam dated 21.04.2025].
